WATER USERS AGREEMENT

Whereas, the Applicant desires to purchase water from the City of Amity and to enter into a water users agreement as required by the City.

NOW THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, it is hereby understood and agreed by the parties hereto as follows:

The City of Amity shall furnish, subject to the limitation set out in its Ordinances, Rules, Resolutions, Regulations, Articles, and Bylaws now in force or as hereafter amended, such quantity of water as Member may desire in connection with Member's occupancy of the aforementioned property.

The City of Amity shall ensure at the location of service a water meter, a cutoff valve and a service line which shall begin at the water main line and extend to the property line. The City of Amity shall have exclusive right to use such cutoff valve and water meter. The service line shall connect with the water main line of the City of Amity at the nearest place of desired use, where the City has determined in advance the system has sufficient capacity to permit delivery of water at that point.

The Applicant agrees to grant to the City, its successors and assigns, a perpetual easement in, over, under and upon the above-described land, with the right to erect, construct, install, and lay, and thereafter use, operate, inspect, repair, maintain, replace, and remove water pipelines and appurtenant facilities, together with the right to utilize adjoining lands belonging to the Applicant for the purpose of ingress to and egress from the above-described lands.

The Applicant shall install and maintain at the Applicant's expense a service line which shall begin at the meter and extend to the dwelling or place of use, if not already installed or serviceable. The service line shall connect to the City's water meter.

The Applicant shall comply with the stipulations established in Amity's Municipal Code (Ordinance 672), regarding the tampering with water meters, removal of City installed locking devices to shut off water, piping or diverting around water meters, and damage done to a City water meter in the act. The Applicant agrees that such actions may result in a Class 2 fine, or Class 1 fine, or Class C felony under ORS 164.345. Upon conviction in Municipal Court, all assessed fines and liability shall be paid in full to continue water service, restore water service, or to close an account, in addition to any other fees or charges assessed by the City.

The Applicant also agrees to be fully responsible for the service line from the water meter to the home/dwelling/building/point of consumption/etc. including the installation of an approved back-flow device if required.

The Applicant agrees to comply with and be bound by the Ordinances, Rules, Resolutions, Regulations, Articles, and Bylaws of the City of Amity, now in force, or as hereafter duly and legally supplemented, amended, or changed. The Applicant also agrees to pay for water at such rates, time, and place as shall be determined by the City, and agrees to the imposition of such penalties for noncompliance as are now set out in the Ordinances, Rules, Resolutions, Regulations, Articles, and Bylaws of the City of Amity or which may be hereafter adopted and imposed by the City of Amity.

The Applicant agrees to pay the deposit as determined by the City. In the event service to the Applicant is terminated, either voluntarily by the Applicant, or by the City of Amity for cause, the deposit shall be held and applied by the City to any unpaid balance then owing on the Applicant's account. Should the account be fully paid at the time of termination of service to the Applicant, the deposit shall be refunded by the City of Amity within a reasonable time thereafter or the Applicant may reclaim the deposit after two years of good payment history.
